Dear Tribal Leader:

The Region 10 Tribal Operations Committee is a partnership between the U.S. Environmental Protection Agency and elected Tribal representatives. The mission of the RTOC is to protect and improve Tribal health and environmental conditions for federally recognized Tribes consistent with the EPA Indian Policy, the federal trust responsibility and environmental laws, policies and guidance. The TOC provides input and guidance to the EPA on a national and regional level on the development of programs and policies impacting Tribes. The EPA is seeking nominations from federally recognized Tribes in Idaho for the TOC Idaho position. The nominee must be an elected Tribal official or staff from a federally recognized Tribal government in Idaho, and willing to serve a three-year term starting on January 1, 2025. TOC representatives also serve as members of the Region 10 Tribal Operations Administrative Consortium, which manages the administrative functions of the RTOC. Nominees to the TOC must obtain a resolution or letter of support from their Tribe in order to be a representative on the TOC.

The RTOC holds two in-person meetings per year. Typically, these meetings are held in Seattle, Washington. The travel costs for elected Tribal representatives on the RTOC to attend these meetings are provided through a cooperative agreement that is awarded by the EPA to the Consortium. In addition, the RTOC holds additional conference calls and assigns workgroups/subcommittees for special tasks as needed.

Representation on the TOC requires a significant time commitment that goes beyond just meeting attendance. Significant time may be spent in coordination with other Tribes and participation in issue formulation and discussion. However, the position offers an opportunity to affect EPA's decisions and relationships with Tribes. All these factors should be considered for anyone interested in pursuing a TOC nomination.

If your Tribe would like to provide a nominee to serve on the TOC, please email the enclosed nomination form, including a brief description of each nominee's background and qualifications, to the EPA by **Friday, November 1<sup>st</sup>, 2024**. I've assigned Lucas Dusablon, RTOC Coordinator, to receive your Tribe's TOC nomination form by email at [dusablon.lucas@epa.gov](mailto:dusablon.lucas@epa.gov). The EPA will email the official TOC ballot to your Tribe. Election results will be announced by the EPA in early December 2024, with the newly elected TOC member starting their three-year term on January 1, 2025.

I appreciate your support as we move forward with this important TOC nomination and election process.
